In 1965, Dr. James B. Conant, a president emeritus of Harvard University, recognized the need for a more unified direction for education policy. He identified the challenging task states were faced with in guiding effective education policy and knew they needed a mechanism to work together. Following many meetings among state leaders came the goal: create a partnership between education leadership and political leadership for the advancement of education through information sharing and collaboration.

Our mission is fueled by the in-depth reports we publish to help state policymakers learn important context and strategies to address pressing education policy issues in their state.

In 2023, we published:

- **Fifteen policy reports** diving into current legislative context on education issues spanning the education spectrum.
- **Eight <u>50-State Comparisons</u>** providing a comprehensive look at how all 50 states and the District of Columbia approach a specific education issue in law or statute.
- Thirty <u>Ed Note</u> blog posts highlighting timely issues, innovative state examples and guest author contributions in an easy-to-read format.

We also offer annual coverage of key happenings like governors' State of the State addresses and state elections to deliver insights that keep our constituents in the know.

Also in 2023, we had the pleasure to publish three blog posts and a <u>Policy Outline</u> for our Immediate Past Chair's Initiative on equitable computer science education access under the leadership of former Arkansas Gov. Community of Practice

Our team is always working on bringing in new opportunities for state policymakers to strategize and collaborate on education policy issues. At our annual Winter Commissioners Meeting, we debuted a **Community of Practice workshop** to provide a new type of learning experience for attendees. This brought together a diverse set of experts and practitioners to highlight our Chair's Initiative on expanding education access for individuals impacted by the justice system. The Community of Practice gave attendees the unique opportunity to hear from experts in different roles who are invested in this issue, ask questions about their experiences and learn about opportunities to expand education access to people impacted by the justice system across states.

RESEARCH AND COUNSEL

Supporting States With Personalized Services

The core of our work is our individualized education policy service to states. We know that state leaders need different kinds of supports depending on their context. In 2023, our team connected with policymakers in all 50 states, territories and the District of Columbia to support key policymaking work in a number of ways:

- Fifty-eight testimonies or presentations given in 26 states, with 21 being to a national audience.
- Fifty-eight technical assistance opportunities provided to policymakers in 34 states and the U.S. Virgin Islands.
- Thirty-eight policy consultations provided to policymakers in 21 states.
- Direct connections made between state policymakers in 11 states for one-on-one learning opportunities.

Additionally, we answered **421** requests for information. This is one of our most popular services, because of our nonpartisan analysis, trusted research and timeliness in response. The topics we received the most questions on were:

State Education Policy Tracking

Our <u>State Education Policy Tracking tool</u> is the foundation of our research and trends work; it informs our analyses and the information we provide states. In 2023, Our Policy Team tracked **7,406** bills in 40 distinct policy issue areas. The high-volume policy areas were:

- K-12 Finance
- Postsecondary Affordability and Finance
